
Introduction

Dennis Grauel – hereafter “Dennis”, owns the fonts enclosed with this license. This license grants the ability to use these fonts – hereafter “Fonts”. Ownership of font design and font software remains with Dennis.

By purchasing a license to fonts, installing fonts or otherwise accessing fonts, you enter into this agreement with Dennis. This license also applies to any fonts thereafter provided as free updates.

Definitions

<i>Fonts</i>	The font files offered by Dennis Grauel
<i>License holder</i>	The individual or organisation purchasing the license. Hereafter “You”.
<i>Licensed User</i>	A person who is permitted by this license to use fonts.
<i>License Scale</i>	The size of the license, defined by organisation scale.
<i>Organisation Scale</i>	The number of people in the license holder’s organisation.
<i>Subcontractors</i>	External professionals, such as printers, who may require access to fonts as part of their service.

License Types

Desktop License

Lets you use fonts on desktop applications:

- Install fonts on any number of computing devices that are exclusively yours or dedicated to licensed users.
- On multi-user computing devices, you may install fonts on user accounts that are exclusively yours or dedicated to licensed users.
- Use fonts in any static medium, such as printed material, signage, logos, or social media.

Web License

Lets you use fonts in web applications:

- Embed fonts in 1 website. A website is a single top level domain (example.com), including subdomains (blog.example.com) and local development environments.
- License fees increase with license scale, irrespective of website traffic.

Trial License

Trial Fonts are free to use. They may be installed on an unlimited number of computing devices for an indefinite period.

Trial fonts must be used for testing purposes only.

You may not modify trial fonts

License Scale - - - - -

The license scale for Desktop and Web license types is defined by the scale of your organisation:

- Organisation scale is the number of people in your organisation.
 - A person is counted in your organisation scale if they are employed by your organisation.
 - Employment is defined as continuous work over a 3 month period. Freelance subcontractors can be considered employed if their work is persistent and ongoing.
- For large organisations, you may define organisation scale by the number of people in your department, providing you can demonstrate that your department has a reasonable degree of independence, and will not share licensed fonts with other departments.
 - For example, an art gallery within a university may operate independently with its own printed material, documents and assets.
- If the number of people in your organisation increases, you are obligated to update your license on a yearly basis. You can do this by contacting Dennis by email. You will be required to pay only the difference between your existing and new license scales.

Permissions & Restrictions - - - - -

You may:

- embed read/write versions of fonts in word-processing documents to be shared with fewer than 20 people outside your organisation
- embed read-only versions (which cannot be used to create new documents) of fonts in files such as PDFs and e-books.
- share fonts with technical subcontractors such as prepress departments, printers or front-end developers, and only when packaged with a project they are used in (for example, a book).
 - Subcontractors are permitted to use fonts only in support of the project(s) in which they are packaged.

You may not:

- distribute fonts to non-licensed users
- distribute modified versions of fonts to
- modify or remove copyright and designer metadata from fonts
- receive technical support for modified fonts
- modify fonts without explicit permission from Dennis

Termination - - - - -

This license remains in effect until terminated.

- You may request a termination by contacting Dennis with confirmation that you have permanently deleted all fonts files, including embedded and modified copies. Refunds are offered for terminations within 30 days of purchase.
- This license will be terminated if it is breached. If terminated, you are required to permanently delete all font files, including embedded and modified copies.
- If you have highly unusual or excessive needs for technical support, Dennis may terminate your license and refund the license fee.

Quality - - - - -

Fonts are offered in various states of completion, on an 'as-is' basis. Dennis's liability to you for damages, costs and losses resulting from your use of the fonts – including third-party claims against you – is limited to a refund of your license fee.

Jurisdiction - - - - -

This license is governed by the laws of the State of Victoria, Australia. If any part of these terms and conditions is unenforceable by the State of Victoria, the remaining terms will continue to apply.
